Service Area

Serving the cities of Dublin, Livermore and Pleasanton, California

The Livermore Amador Valley Transit Authority (LAVTA), with its focus on passenger service, provides a reliable, safe, comfortable means of mobility to citizens of the Tri-Valley.

The Tri-Valley area is located 39 miles east of San Francisco, California and 28 miles north of Silicon Valley. This area is crossroads for commuter traveling from the Central Valley to Silicon Valley and other employment destinations. With a combined popular of over 200,000 residents, the Dublin-Livermore-Pleasanton area is one of the fastest growing in the Bay Area.



Organization

The Livermore Amador Valley Transit Authority (LAVTA) was formed in 1985 under a Joint Powers Agreement to provide public transit in the cities of Dublin, Livermore, Pleasanton and in nearby unincorporated areas of Alameda County. LAVTA is governed by a seven member board of directors composed of two elected officials from each City and one member appointed by the Alameda County Board of Supervisors.

Passenger Services / Facilities

The Authority provides the following named transportation services:

- Wheels Fixed Bus Route service
- Tri-Valley Rapid Bus Rapid Transit service
- Dial-a-Ride Paratransit service

Wheels and Tri-Valley Rapid services are operated and maintained through a contract with MV Transportation. Dial-A-Ride service is operated and maintained through a contract with MTM Transportation.

Regional Connections

Wheels buses connect with two San Francisco Bay Area Rapid Transit (BART) stations and three Altamont Commuter Express (ACE) Rail stations in Livermore and Pleasanton. Wheels also connects with six other public transportation systems including the Central Contra Costa Transit Authority (County Connection), Amtrak, the Modesto Area Express (MAX), SolTrans, the San Joaquin Regional Transit District (RTD) and West Contra Costa Transit Authority (WestCAT).
