**Operating Expenditures Summary:**

As this is the twelfth month of the fiscal year, in order to stay on target for the budget this year expenses (at least the ones that occur on a monthly basis) should not be higher than 100%. The agency is at 91.26% overall.

***Operating Revenues Summary:***

While expenses are at 91.26%, revenues are at 94.3%, providing for a healthy cash flow. Not all accounts have been closed out for the year so the expense and revenue balance will change, and the board will be updated.
