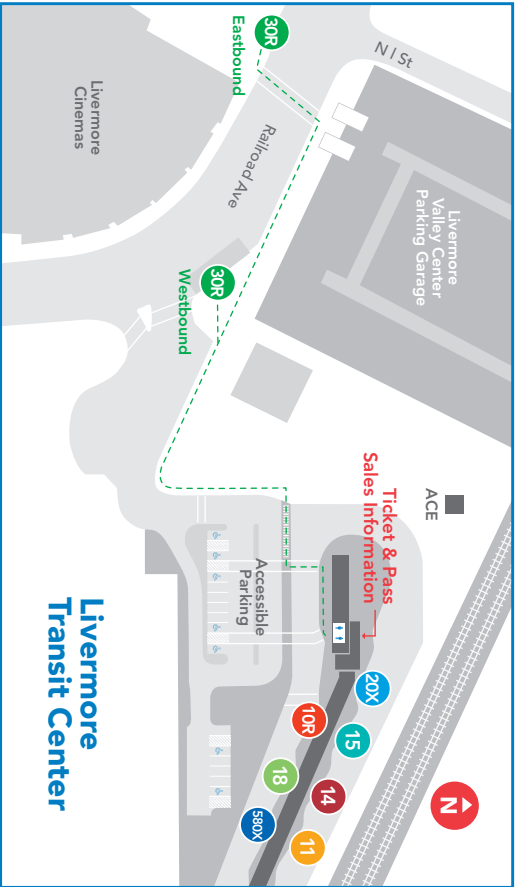

Bus Riding Basics

- Arrive at your bus stop 5 minutes early.
- Buses stop at designated stops only.
- Exact fare only; drivers do not carry change.
- Smoking, vaping, eating and drinking are prohibited.
- Headphones are required for all audio playback.
- Wheelchair ramp is available on all buses.
- Buses are equipped with bicycle racks. If the rack is full, bikes may be allowed onboard at driver's discretion.

ADA / Title VI



The Americans with Disabilities Act of 1990 (ADA) guarantees persons with disabilities full and equal access to the same services and accommodations that are available to people without disabilities.

Title VI is a section of the Civil Rights Act of 1964 requiring that “No person in the United States shall on the grounds of race, color or national origin, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving federal financial assistance.” If you believe that you have received discriminatory treatment by Wheels on the basis of your race, color or national origin, you have the right to file a complaint with the Wheels Title VI Coordinator.
